

Terms of Service:

The following terms and conditions govern all use of the HolisticBodyWorksForWomen.com website and all content, services and products available at or through the website (taken together, the Website). The Website is owned and operated by Holistic BodyWorks for Women ("Holistic BodyWorks for Women"). The Website is offered subject to your acceptance without modification of all of the terms and conditions contained herein and all other operating rules, policies (including, without limitation, Holistic BodyWorks for Women's Privacy Policy) and procedures that may be published from time to time on this Site by Holistic BodyWorks for Women (collectively, the "Agreement").

The arbitration shall take place in Ann Arbor, Michigan, in the English language and the arbitral decision may be enforced in any court. The prevailing party in any action or proceeding to enforce this Agreement shall be entitled to costs and attorneys' fees. If any part of this Agreement is held invalid or unenforceable, that part will be construed to reflect the parties' original intent, and the remaining portions will remain in full force and effect. A waiver by either party of any term or condition of this Agreement or any breach thereof, in any one instance, will not waive such term or condition or any subsequent breach thereof. You may assign your rights under this Agreement to any party that consents to, and agrees to be bound by, its terms and conditions; Holistic BodyWorks for Women may assign its rights under this Agreement without condition. Privacy Policy:

Holistic BodyWorks for Women ("**Holistic BodyWorks for Women**") operates HolisticBodyWorksForWomen.com and may operate other websites. It is Holistic BodyWorks for Women's policy to respect your privacy regarding any information we may collect while operating our websites.

Website Visitors
